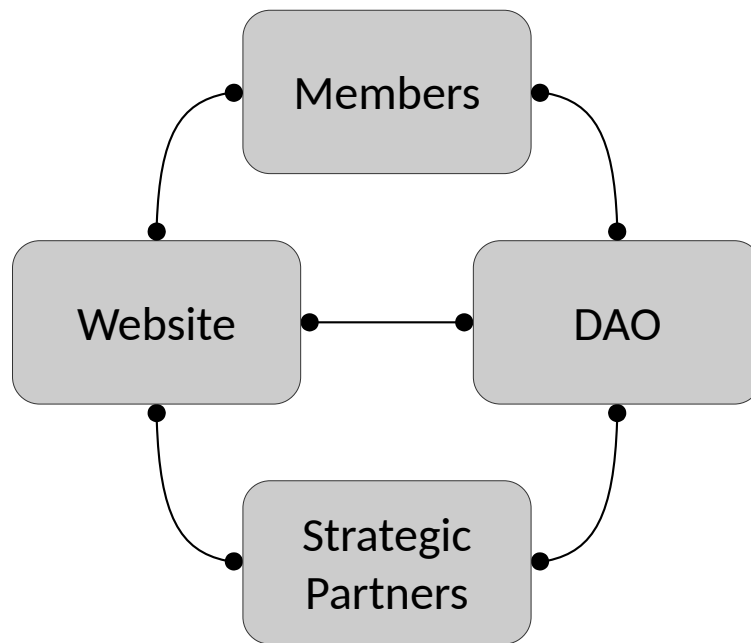


Figure 1: The relationship between the four components of Arphicia

PROJECT MANAGEMENT

- **Purpose:** Enable clients to initiate projects within the collective, which will contain specific tasks.
